You may want to make a final adjustment on the labels you put out in the marketplace. The calorie content is missing the kcal ME/kg and federal USFPLA requires an actual net weight statement. You can include the treat count as well. Good luck!

Calorie statements are required on dog and cat foods and treats and should be separate from the guaranteed
analysis and should appear under the heading 'Calorie Content' and be in terms of metabolizable energy (ME),
on an as-fed basis, and expressed as 'Kilocalories per kilogram" (kcal/kg) of product and Kilocalories (kcal) per
familiar household measure. Please refer to AAFCO Official Publication PF9.

For ex (food):

CALORIE CONTENT (calculated)
3200 kcal ME/kg; 32 kcal ME/cup

For ex (treat):

**CALORIE CONTENT (calculated)** 

3200 kcal ME/kg; 3.2 kcal ME/treat

• Include both US standard and metric units in the net weight statement which should appear in the bottom third of the principal display panel. For example: Net Wt 5 lb (2.27 kg). Please refer to the United States Fair Packaging and Labeling Act of 15 USC 1451 through 1461.
