Dear Cottage Food Producer:

SB 159, also known as the Cottage Food Bill, requires Cottage Food Producers to register with the local health department. Your registration has been reviewed and meets the requirements of SB 159. Enclosed is a copy of your registration; the original is on file in our office.

The Health Department does not issue permits for Cottage Food Producers in accordance with the law. The health department review indicates compliance with that stipulation in the Cottage Food Law, and does not indicate compliance or exemption from the requirements of other jurisdictions, such as business license, zoning, and building or fire codes.

The health department will not regulate Cottage Food producers, but may investigate complaints if received. The health department will only take enforcement action if the Cottage Food Producer is not acting in accordance with SB 159, such as selling foods other than submitted for review or that are not exempted from regulation by SB 159; or not selling directly to the consumer (such as placement for sale in store, or selling to food establishments for service or sale).

Your registration for Cottage Foods is active until **8/10/2024**. At that time you will need to register an updated Food Certificate of Training to continue operating as a Cottage Food producer.
