### EVALUATION COMMENT

The firm is a wholesale processor of pierogis (15-20 varieties). They wholesale 8 varieties of pierogis to Cherry Capital for further distribution; the other varieties are sold retail. The firm has 14 employees and operates inside of Gratiot Central Market. There hours are Monday through Friday, 8a-4p (production), and Saturday, 9a-4p (cooked-to-order and retail sales). The space is equipped with a walk-in-cooler, walk-in-freezer, 3-compartment warewashing sink, prep sinks (2), handwashing sinks (2), and cooking equipment under a ventilation hood. The Sports Bar pierogi (chicken, potato, cheddar cheese, ranch mix, buttermilk, and hot sauce) was produced during the inspection (flow chart attached).

The pierogis that contain meat are under the threshold for USDA jurisdiction. The pierogis are sold frozen with a 6-month shelf-life. They are packaged in dozens; 1 batch is approximately 2 ½ cases (12 dozen packs/case). The firm is in the process of changing their labels and was instructed to have the labels reviewed beforehand.

FSMA information provided to firm for review; the firm has submitted the paperwork for a Qualified Facility.
