Dear Jamie Condon:

The information that you submitted for your cottage food business to sell Apple Butter, Blackberry Jam, Raspberry Jam and Strawberry Jam at Farm Chicks Corner Market, 1141 Berryman's Ln, Reisterstown, MD 21136, has been reviewed. It has been determined that the items offered for sale, location of sale, food safety course certification, and labels meet the requirements of the Code of Maryland Regulations (COMAR) 10.15.03 and Health General Article, §21–330.1.

The status of your application with the Maryland Department of Health will be shared with local area health departments. Please be reminded that all cottage food items offered for sale must be prepackaged with the reviewed label affixed to the product, and **all cottage food product sales are limited to within the state of Maryland**. Interstate sales are prohibited. Additionally, meeting the requirements for selling your cottage food products to a retail food store is not a Food Processor's License or a Retail Food Facility License. No license is issued for cottage Foods.

Submission of additional information is required prior to:

1. The expiration of the current food safety course certificate (i.e. you cannot sell the items listed above unless your certification is current and on file with this Office).
2. Adding new cottage food items offered for sale at retail.
3. Changing or adding location(s) of sale.
4. Modifying labels.
5. Changing recipes and/or ingredients.
6. Changing location or contact information (i.e. business name, address, phone number, or email) for the cottage food business.
7. Approaching \$25,000 in annual sales (i.e. the cottage food business is nearing capacity for annual revenue).

Contact this Office prior to making any changes as specified above to ensure compliance with current requirements of the Code of Maryland Regulations (COMAR) 10.15.03 and Health-General Article, §21-330.1.
